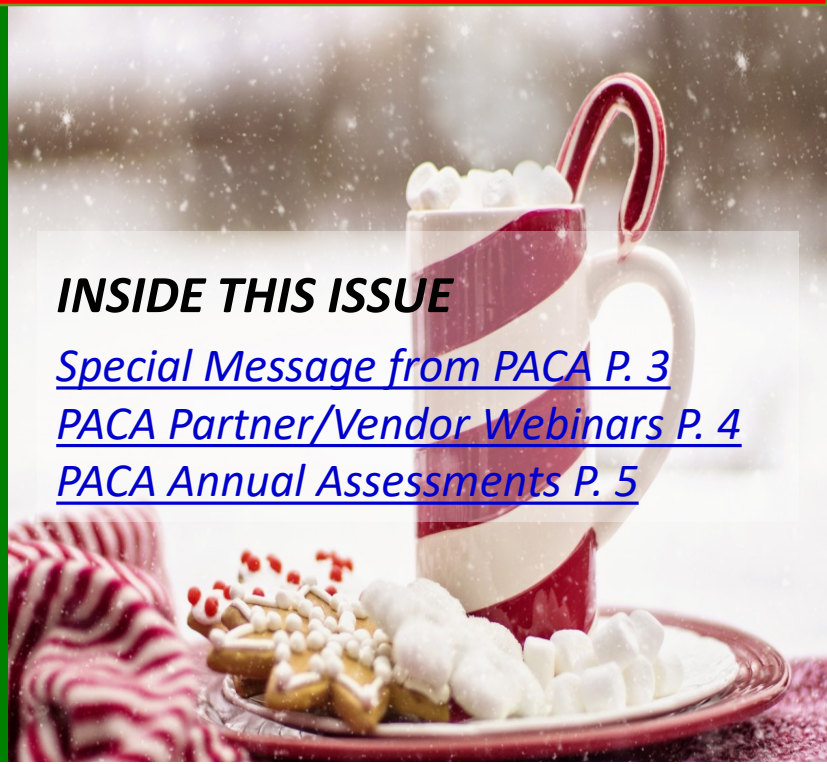

- *Other Organization* are calculated based on the most recent audited budget/financial report.
- PACA Partnership fees are calculated by PARCA, (Public Affairs Research Council of Alabama) a non-profit agency.
